

Sugarland neighborhood members, whose houses are adjacent to Reston, will be permitted to purchase reduced price non-resident family pool and tennis passes for the 2014 season within the conditions below.

Sugarland neighborhoods include UMHOA, NPG and SRA. The discounted rate is available for any person residing on one of the following streets: **Coat Ridge, Heather Down, Forbes Glen, Malvern Hill, North Point Glen, Rosiers Branch, Stuart Ridge, Trossack, and Winding Way.**

1. Non-resident family pass pricing for the 2014 season will be \$445.00 per household for a “Pool only” membership or \$475.00 for a “Pool and Tennis” membership. This is a \$150 discount off the full price.
2. Sugarland neighborhood must ensure a minimum of 29 households participate at the above listed rate for the rate to be effective
3. Should less than 29 households purchase non-resident family passes, Reston Association (RA) reserves the right to either:
 - a. Shorten the pass season to July 5, or
 - b. Pull the passes and disallow access to those who have purchased passes and refund the prorated amount from the date of purchase to the date passes are pulled – based upon a 141 day season – plus a 10% administrative fee.
 - c. Offer households that have purchased passes to pay the difference between the full market/published rate and their initial discounted rate if they want to continue use of the RA facilities for the remainder of the pool season.
4. Household representative (18 years or greater) agrees to the above by signing this agreement below.
5. This agreement will be in effect for the 2014 aquatics season as set by RA each year.
6. All Sugarland neighborhood members must abide by established rules of use for the aquatics facilities, as posted at each facility.
